The Accreditation Assessment Team from the New Jersey State Association of Chiefs of Police Invites Public Comment on Marlboro Police Departments State Accreditation assessment.

Accreditation Assessment Team Invites Public Comment

(Marlboro/Monmouth County, NJ) A team of assessors from the New Jersey State Association of Chiefs of Police (NJSACOP) will arrive on Sunday, August 13th 2017, to examine all aspects of the Marlboro Township Police Department policies and procedures, management, operations, and support services Chief Bruce E. Hall announced today.

“Verification by the team that the Marlboro Township Police Department continues to meet the Commission’s “best practice” standards is part of a voluntary process to achieve re-accreditation, a highly prized recognition of law enforcement professional excellence”, Chief Bruce E. Hall said.

As part of this final on-site assessment for re-accreditation, employees and members of the general public are invited to provide comments to the assessment team. They may do so by telephone or email. The public may call (732) 536-6914 on Sunday, August 13th 2017, between the hours of 10:00am and 12:00pm. Email comments can be sent to abilinski@marlboropd.org

Telephone comments are limited to 5 minutes and must address the agency’s ability to comply with the NJSACOP standards. A copy of the standards is available for inspection at the Marlboro Township Police Department at 1979 Township Drive, Marlboro NJ 07746. Please contact Lieutenant Allan Bilinski at (732) 536-5432.

Anyone wishing to offer written comments about the Marlboro Township Police Department’s ability to comply with the standards for accreditation is requested to write: New Jersey State Association of Chiefs of Police, Law Enforcement Accreditation Commission at 11,000 Lincoln Drive West, Suite 12 Marlton, N.J. 08053.

The Marlboro Township Police Department must comply with 100 standards in order to achieve accredited status. The Marlboro Police Department indicated, *“Accreditation results in greater accountability within the agency, reduced risk and liability exposure, stronger defense against civil lawsuits, increased community advocacy, and more confidence in the agency’s ability to operate efficiently and respond to community needs.”*

The Accreditation Program Manager for the New Jersey State Association of Chiefs of Police is Mr. Harry J Delgado. *“The assessment team is composed of law enforcement practitioners from similar New Jersey law enforcement agencies. The assessors will review written materials, interview agency members, and visit offices and other places where compliance with the standards can be observed. Once the Commission’s assessors complete their review of the agency, they will report to the full Commission, which will then decide if the agency is to be granted accredited status”*, Harry J Delgado stated.

Accreditation is valid for a three-year period during which time the agency must submit annual reports attesting to their continued compliance with those standards under which it was initially accredited.

The New Jersey State Association of Chiefs of Police through its New Jersey Law Enforcement Accreditation Commission is the legitimate authority and accreditation agency in the state of New Jersey.
