Each application must be accompanied by a check for \$3,100 as the initial application fee and license for one year. The annual renewal fee is as follows: \$1,250 in 2024; \$2,500 in 2025; \$3,100 in 2026. This fee is non-refundable.

Within ten (10) days of the granting of the license the licensee shall be required to post a ten thousand dollar (\$10,000.00) Bond with the Township. Said Bond shall contain the following language: "The obligation of this bond shall, in addition to the Township of Marlboro, be and remain for the benefit of any person who shall obtain a judgment against obligor as a result of damage sustained in operation pursuant to any license granted under this chapter."

Said Bond shall be kept in force for a minimum period of one (1) year from date of issuance of the license and must be renewed annually along with the license.

Every applicant should familiarize his/her self with Chapter 206 of the Code of the Township of Marlboro.
