#### Certificate of Insurance

All sponsors and vendors, regardless of level of participation, are required to provide a valid **Certificate of Insurance (COI)** evidencing an Occurrence Based Liability Insurance Policy with a minimum of \$1,000,000. This can be obtained from your insurance carrier.

The COI must contain the following information:

- 1. The box labeled Description of Operations, usually toward bottom of the form, it must have Marlboro Township is listed as additionally insured with the date of September 8th, 2024 with a rain date of September 15th, 2024.
- 2. The box labeled **Certificate Holder**, usually located in the bottom left corner, must have the following information listed in the box, **Marlboro Township**, **1979 Township Road**, **Marlboro**, **NJ**, **07746.** Please **DO NOT use the Recreation name and address**.
