Certificate of Insurance

1. The box labeled Description of Operations, usually toward bottom of the form, it must have **Marlboro Township is listed as additionally insured with the date of September 8th, 2024 with a rain date of September 15th, 2024.**
2. The box labeled **Certificate Holder**, usually located in the bottom left corner, must have the following information listed in the box, **Marlboro Township, 1979 Township Road, Marlboro, NJ, 07746. Please DO NOT use the Recreation name and address.**
