<u>P.B. 1146-16 HARBOR ROAD WATER TREATMENT PLANT – REVIEW & RECOMMENDATION</u>

This application is for the replacement of the existing water treatment plant located at the Water Division property, located at 14 Harbor Road Block 171 Lot 71, with a new treatment plan. Also a new parking/driveway and stormwater management facilities.

Ms. Neumann, P.E., P.P. stated that Dean Staknys, P.E., assistant Township Engineer reviewed this application and had the following comments:

- 1. The project is part of the Capital Improvement Program by the Marlboro Water Division and the construction will be monitored by CME Associates
- 2. The existing treatment plant will continue to operate during construction
- 3. Zoning/construction permits as required.

The Board had no specific concerns with this application.

P.B. 1145-16 CUZINS <u>CLAM BAR, LLC – PUBLIC HEARING – MINOR SITE PLAN</u>

Mr. Herbert, Esq. noted that the affidavit of publication and notice to adjoining property owners have been reviewed and are in order, therefore the Board has the jurisdiction to hear this matter.

Salvatore Alfieri, Esq. represented the applicant. The site contains 849 feet of frontage along Route 79 to the east and 240 feet of frontage along Old Mill Road to the south, within the C-5 zone, Block 413 Lot 35. Currently the property is developed as Maple Tree Plaza consisting of 2 one story multi-tenant commercial buildings and a day care facility with fence enclosed attached playground areas, with paved parking for 209 vehicles.

The applicant is seeking Site Plan approval to enclosed an outdoor dining area along the north side of the existing restaurant with removable glass panels. The enclosure is approximately 2,650 s.f. in area and provides an additional 36 seats to the restaurant.

Charles Mayo, owner stated that he had temporarily enclosed the outdoor patio. The restaurant has been opened for 6 weeks and the patio itself was approved for the site but the enclosure was not and he apologized for the enclosure being done with Board approval. He agreed to place bollards around the enclosed patio and he said he will be installing windows so the enclosure can remain heated.

Ms. Neumann. P.E., P.P. reviewed her report with the Board and answered questions.
