MARLBORO TOWNSHIP COUNCIL MEETING

June 15, 2023

The Marlboro Township Council held its regularly scheduled meeting on June 15, 2023 at 7:00 P.M. at the Marlboro Township Municipal Complex located at 1979 Township Drive, Marlboro, New Jersey.

Council President Qazi opened the meeting and announced that pursuant to the provisions of the Open Public Meetings Act, notice of this regularly scheduled meeting of the Township Council of the Township of Marlboro was sent to the Asbury Park Press, the Star Ledger and the Board of Education Office on June 13, 2023; published in the Asbury Park Press on November 16, 2022; posted on the Bulletin Board of the Municipal Building; filed in the office of the Municipal Clerk and placed on the Township website and Channel 77.

The Deputy Municipal Clerk called the Roll.

PRESENT: Council Vice President DiNuzzo, Councilwoman Marder, Councilman Milman, Councilman Scalea and Council President Qazi.

> Also present: Mayor Jonathan L. Hornik, Township Attorney Louis N. Rainone, Esq., Business Administrator Jonathan Capp and Deputy Municipal Clerk Jennifer M. Johnson

<u>Council Speaks Out</u>: Councilman Milman asked that all residents be diligent with keeping their homes and cars lock to prevent theft. He also thanked the Marlboro Police Department for keeping Marlboro residents safe. Council Vice President DiNuzzo wished everyone a Happy Father's Day and Happy Juneteenth. Council President Qazi provided updates concerning the Township Police and Public Works departments.

Administration Report: Mayor Hornik offered updates about upcoming Township events in July: Marlboro summer concert with fireworks and National Night Out. He requested support from the council for the following agenda items: road improvement grants for Wyncrest Road, a portion of Robertsville Road, Brookside Circle, Union Hill Road, Woodstock Terrace and an upgrade to recreational parks and Topanemus Road sidewalk improvements. He recently testified before the state assembly in favor of reducing property taxes for seniors by fifty percent. The statae assembly committee approved the bill and it has been referred to the state budget and appropriations committee. He would also be testifying in Trenton in favor of restoring the state budget cuts that will force the Freehold Regional High School District to reinstate courtesy busing this September. He wished all Marlboro Township graduates all the best in the next chapter of their lives. He wished everyone a Happy Juneteenth and a Happy Father's Day. He hoped to see everyone at the Marlboro Farmers Market.

Presentation of the Law Enforcement Torch Run for the start of the Special Olympics. Officer James Caulfield of the Marlboro Police Department offered the presentation. Officer Caulfield recognized athletes and volunteers for their involvement in the Special Olympics. He presented Mayor Hornik with a plaque, thanking him for his continued support of the Marlboro Township Police Department, the Special Olympics and for all he continues to do for the Marlboro community.

Councilman Scalea moved that the Council meeting minutes of May 18, 2023 be approved. This was seconded by Council Vice President DiNuzzo, and passed on a roll call vote of 5 - 0 in favor.

ORDINANCE #2023-017

AN ORDINANCE OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY, APPROPRIATING A \$447,000 GRANT TO BE RECEIVED BY THE TOWNSHIP FOR IMPROVEMENTS TO TOPANEMUS ROAD SIDEWALKS IN AND FOR THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY

BE IT ORDAINED, BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MARLBORO, IN THE COUNTY OF MONMOUTH, NEW JERSEY (not less than a majority of all members thereof affirmatively concurring), AS FOLLOWS:

<u>Section 1</u>. The \$447,000 grant expected to be received by the Township from the NJDOT Local Transportation Fund Program (Fiscal Year 2023) is hereby appropriated for the purpose of providing funds for improvements to Topanemus Road Sidewalks, including all work and materials necessary therefor and incidental thereto.

Section 2. The capital budget or temporary capital budget, as applicable, of the Township is hereby amended to conform with the

provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Municipal Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect in accordance with law.

WHEREAS, the US Department of Housing and Urban Development is sponsoring the FY2024 Community Development Block Grant (CDBG) program which will provide funding through a consortium of Monmouth County municipalities of which Marlboro is a member; and

WHEREAS, the Township has been advised that it is eligible to apply for funding for Greenbriar Road Improvements Phase II (Murray Hill Terrace); and

WHEREAS, the Department of Public Works has identified several roadway and drainage improvements that are required within the Greenbriar Development which may be eligible for funding; and

WHEREAS, the Township of Marlboro is interested in seeking out alternative sources of funding for public improvements; and

WHEREAS, the Mayor and Township Council of the Township of Marlboro wish to apply for funding under the FY2024 CDBG Program.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Marlboro that Marlboro Township hereby endorses the submission of a grant application for FY2024 CDBG funding for Greenbriar Road Improvements Phase II (Murray Hill Terrace).

WHEREAS, the Monmouth County Board of County Commissioners has approved an Open Space Trust Fund and established a Municipal Open Space Program to provide Program Grant funds in connection with municipal acquisition of lands for County Park, recreation, conservation and farmland preservation purposes, as well as for County recreation and conservation development and maintenance purposes; and

WHEREAS, the Governing Body of the Township of Marlboro desires to obtain County Open Space Trust Funds in the amount of \$215,000.00 to fund improvements to The "Tennent Road Walking Trail" project within the Township of Marlboro (Block 267, Lots 41 and 42); and

WHEREAS, the total cost of the project including all matching funds is \$430,000.00; and

WHEREAS, the Township of Marlboro is the owner of and controls the project site.

NOW, THEREFORE, BE IT RESOLVED, BY the Marlboro Township Council THAT:

- Mayor Jonathan Hornik or his/her successor is authorized to (a) make an application to the County of Monmouth for Open Space Trust Funds, (b) provide additional application information and furnish such documents as may be required for the Municipal Open Space Grants Program and (c) act as the municipal contact person and correspondent of the above named municipality; and
- 2. The Township of Marlboro is committed to this project and will provide the balance of funding necessary to complete the project as described in the grant application in the form of non-county matching funds as required in the Policy and Procedures Manual for the Program; and
- 3. If the County of Monmouth determines that the application is complete and in conformance with the Monmouth County Municipal Open Space Program and the Policy and Procedures Manual for the Municipal Grants Program adopted thereto, the municipality is willing to use the approved Open Space Trust Funds in accordance with such policies and procedures, and applicable federal, state, and local government rules, regulations and statutes thereto; and
- 4. Mayor Jonathan Hornik or his/her successor is hereby authorized to sign and execute any required documents, agreements, and amendments thereto with the County of Monmouth for the approved Open Space Trust Funds; and
- 5. This resolution shall take effect immediately.

WHEREAS, New Jersey has adopted NIMS as the State standard for incident management and mandated its use for all emergency incidents in the State; and

WHEREAS, the New Jersey All-Hazards Incident Management Team (NJ-AHIMT or "the Team") was established in 2018 as the State's Type 3 deployable all-hazards incident response management system, see NJ Office of Emergency Management Directive NJOEM-10 (2022), to provide a comprehensive Statewide resource, to assist federal, state, county or municipal agencies or offices of emergency management, by providing incident support and incident management functions, in response to a domestic incident, disaster or emergency; and

WHEREAS, this Agreement is intended to set forth the roles and responsibilities of NJOEM, the Participating Agency, and the Participating Team Members in engaging in preparatory and response activities; and

WHEREAS, the Mayor and Township Council wish to ensure that the Township of Marlboro is in the best position to prevent, prepare for, respond to and recover from emergencies, and recognizes that coordinated incident management through the New Jersey Office of Emergency Management is critical in this regard.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Marlboro, that Mayor Jonathan L. WHEREAS, an active shooter scenario in Marlboro would likely result in a response from a number of different neighboring law enforcement agencies; and

WHEREAS, it is to the benefit of Marlboro and other neighboring Monmouth municipalities to coordinate training together on response and entry tactics, site command and organizational strategy; and

WHEREAS, Freehold Township ("Freehold") has agreed to serve as lead agency in a cooperative effort with Marlboro, Manalapan, Freehold Borough, Howell, Colts Neck, Englishtown, Allentown Borough and the Monmouth County Sheriff's Office to ensure the highest level of coordination by facilitating interdepartmental training on a regular basis for the joint response to active shooter and joint law enforcement emergencies ("Western Monmouth Active Shooter Training Group"); and

WHEREAS, Freehold has proposed an annual budget of \$8,000.00 to cover the costs of certain protective gear, simunitions, planning and execution materials and other incidental costs; and

WHEREAS, Freehold has proposed that the costs be shared on a proportional basis based upon the number of sworn officers in each department; and

WHEREAS, Marlboro's calculated share of the costs of participation in the consortium is \$1,000.00; and

WHEREAS, funds in the amount of \$1,000.00 have been certified by the Chief Financial Officer and are available in Account # 01-201-25-106-285; and

WHEREAS, the Township Council of the Township Marlboro desires to ensure that the highest level of trained and coordinated resources be available to respond to an event in Marlboro, and supports participation in the Western Monmouth Active Shooter Training Group to further that objective.

NOW, THEREFORE BE IT RESOLVED, by the Mayor and Council of the Township of Marlboro as follows:

1. The above recitals are hereby incorporated into the body of this Resolution as if set forth at length herein.
